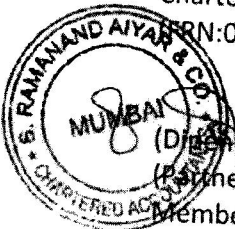
Review Report to: Garbi Finvest Limited (formerly Golden Properties & Traders Ltd.)
